HYDROELECTRIC POWER STATION

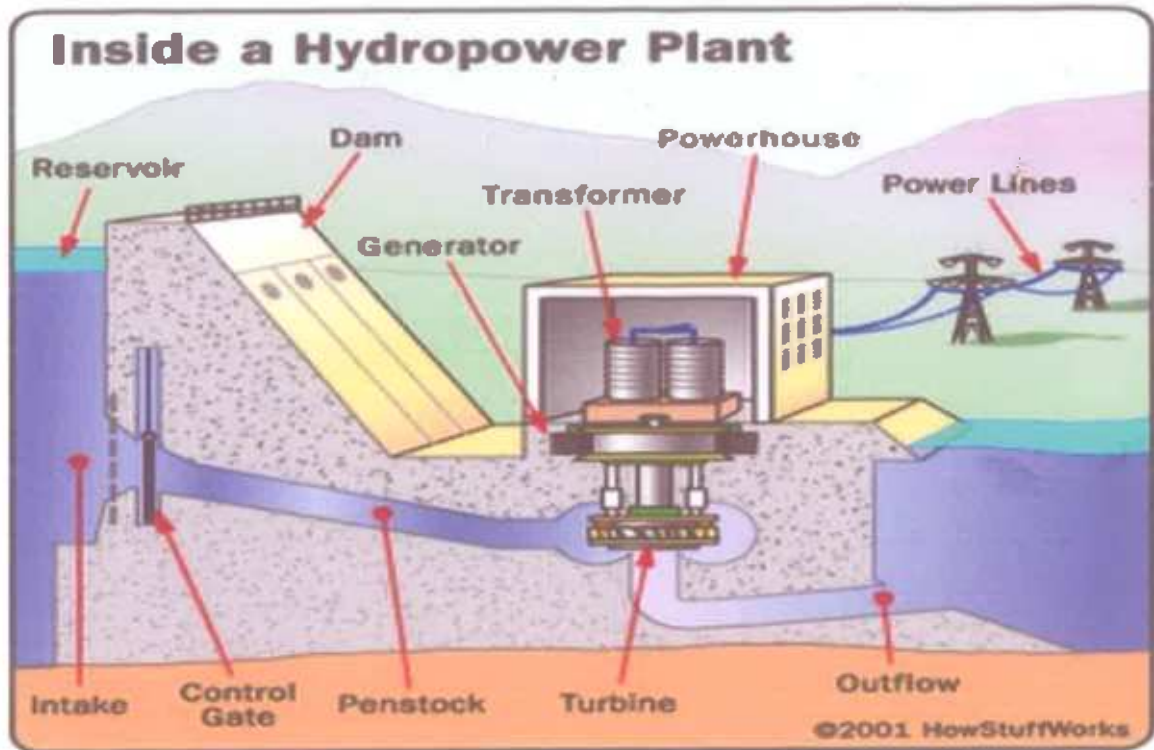
For the subject of “Water Resources Engineering” offered in 8th semester of Civil Engineering , so improve our knowledge , we were arranged a technical visit on Narmada Sarovar Dam in Gujarat on 22nd March 2015. We reached Narmada Sarovar (Gujarat) by college bus at 12:00 pm.



The security and other terms and conditions related to Hydro Power Station are done after the waiting for one hour. All the students were first visited to control room and give the valuable information and layout the structure of Hydro Power Station by the technical assistant Mr. S.S Patel.



❖ LAYOUT OF HYDROELECTRIC POWER PLANT



It's a general layout given by above. Hydroelectric Power Plants convert the hydraulic potential energy from water into electrical energy. The main component of this power station were Dam, Spillway, Penstock & Tunnel, Surge Tank and Power Station.

The Narmada Sarovar Dam is located at Gujarat state on Narmada river in Narmada District. There are six units of hydro turbine each of 200 MW with a total installed capacity of 1450 MW. Basically it is done by two ways a river bed power house generates 1200MW and Canal head power house generates 250MW.

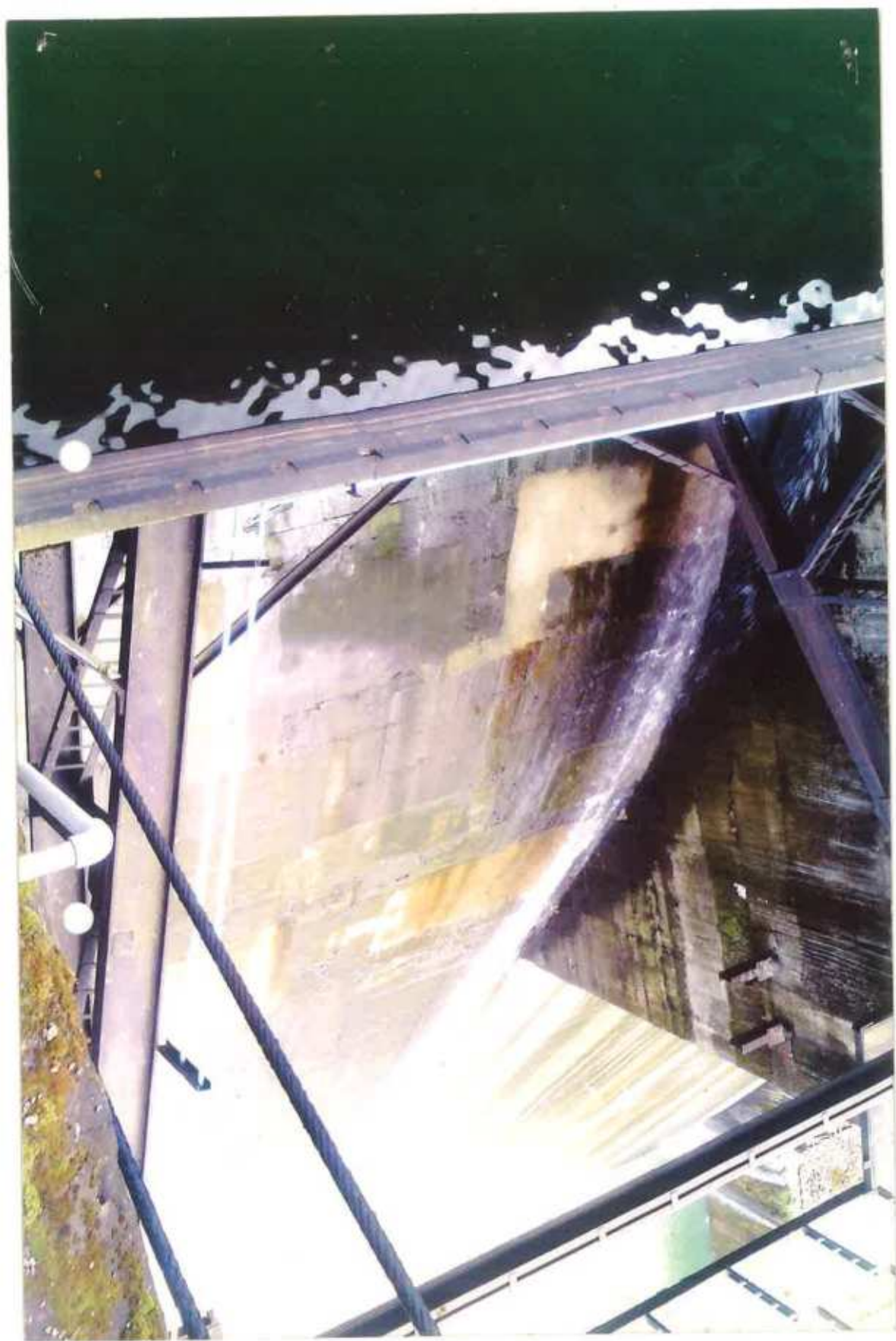

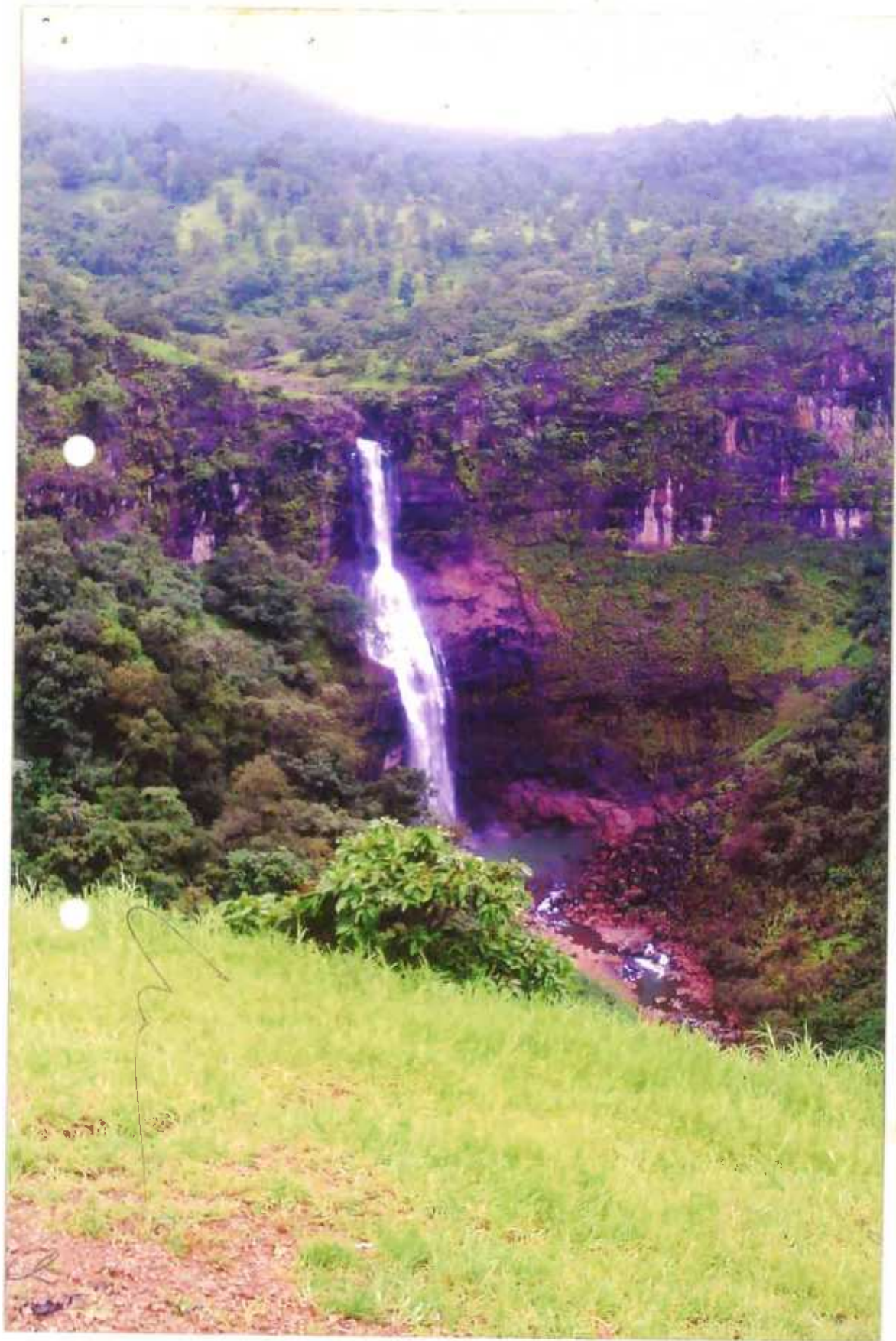

A VISIT TO BHATSA DAM



VISIT REPORT ON BHATSA DAM

The visit location is BHATSA hydro power station, which is situated in BHATSA River. The main location of power station is mauje sajevali Tal. Sahapur, Dist. Thane. There are different parts of dam i.e. embankment of dam, galleries of dam, spillway, power station, gates of dam, surge tank etc.

Basically "BHATSA DAM" is gravity dam having the capacity of water up to 976.100 lakh m^3 . The construction of dam is based upon uncoarse rubble masonry. The height of dam is 89m from ground level, length of dam is 959.0m, the d/s of dam is 79.2m, the u/s is 142.06m. The high flood level of dam = 10242.075 m^3/s . The no. gates situated = 5 Nos. In BHATSA, the storage capacity on electricity is 1*15 MW. Radius of power station is 2.70m also out of storage water in the dam 65% water is used for BMC and 20% water is used for irrigation and 15% water is used for electricity generation.

The main control office of BHATSA dam is in city 'Thane'.

A Visit to Ultra Tech Cement



VISIT REPORT ON R.M.C PLANT

The visit location is ready mix concrete (RMC). The plant belongs to Ultra Tech cement co. Ltd. Known as the unit of Ultra Tech concrete situated in satpur MIDC, Tryambak Road, Nasik.

The details regarding the plants, equipments and their working and Laboratory for quality control and various tests carried out on concrete components etc. It goes through the whole mixing process of concrete, equipments, machineries and other practical aspects of RMC concrete. The visit shows how the material enters the plant then it is collected in bins, silos and other storage compartments, aggregate divided into two parts first in 10mm size and other is 20mm size. The producing concrete material is filled in a loading hopper after which by using a conveyor belt is transported to an overhead bin. The proportion of material is already decided and which depends upon the required production.

The visit given the study and understanding the difference between the ordinary process of concrete and RMC. RMC has more strength as compared to ordinary process concrete.

A patent gives you the right to stop others from copying, manufacturing, selling or importing your invention without your permission. See protecting intellectual property. You get protection for a pre-determined period, allowing you to keep competitors at bay. You can then use your invention yourself. Alternatively, you can license your patent for others to use it or you can sell it. This can provide an important source of revenue for your business. Indeed, some businesses exist solely to collect the royalties from a patent they have licensed - perhaps in combination with a registered design and trade mark. Innovation is a new solution to a technological problem that can be protected by licences or patents. Patent secures the interests of innovators whose tools or ideas are genuinely noteworthy and financially fruitful, by guaranteeing that a founder or creator can control the business utilization of their idea. An individual or organization that holds a patent over innovation has the privilege to keep others from manufacturing, trading, retailing, or stealing that innovation. This provides opportunities for creators to sell, exchange, or accredit their licensed ideas to others who may wish to use them.

Copyright refers to the legal right of the owner of intellectual property. In simpler terms, copyright is the right to copy. This means that the original creators of products and anyone they give authorization to are the only ones with the exclusive right to reproduce the work. Copyright law gives creators of original material the exclusive right to further use and duplicate that material for a given amount of time, at which point the copyrighted item becomes public domain. Copyright is a legal term describing ownership of control of the rights to the use and distribution of certain works of creative expression, including books, video, motion pictures, musical compositions and computer programs. Historically, copyright law has been enacted to balance the desire of cultures to use and reuse creative works -- thus creating "derivative work" - against the rights of authors of art, literature, music and the like to monetize their work by controlling who can make and sell copies of the work. To strike this balance, the exclusivity of control is almost always restricted to a set period of years, after which a copyright-protected work reverts to the public domain and may be freely used.

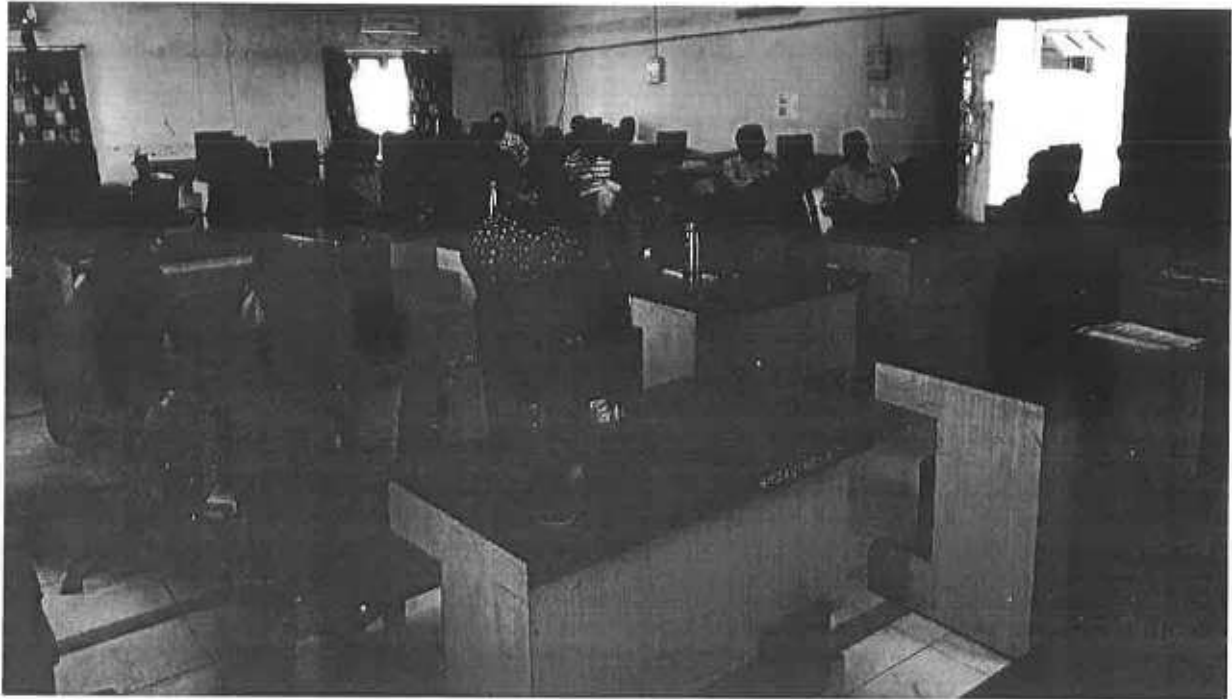
